



BLUEMED is the research and innovation Initiative for promoting the blue economy in the Mediterranean Basin through cooperation. It is the strategy of reference for the Mediterranean countries to work together for a and productive safe healthy. Mediterranean Sea. The BLUEMED Initiative will contribute to create new 'blue' jobs, social wellbeing and a sustainable growth in the marine and maritime sectors through the implementation of its Strategic Research and Innovation Agenda, the BLUEMED SRIA. Coordination and integration of efforts among all stakeholders is key to fulfil the BLUEMED objectives.

#### Governance

The **Strategic Board** steers and promotes the BLUEMED Initiative, favouring the adoption of the BLUEMED agenda at country level and alignment of strategies. Coordinated by Italy, the European Commission (**DG R&I - DG MARE**), It is joined by reresentatives from Croatia, Cyprus, France, Greece, Malta, Slovenia, Spain, Portugal, Belgium, and Montenegro.

### The SRIA

The BLUEMED Strategic Research and Innovation agenda addresses crucial challenges for the Mediterranean Basin and encompasses goals and actions to tackle them with the objectives of filling knowledge gaps, promoting activities enabling the blue growth, and developing measures for capacity creation and skills' enhancement.

## Key Steps

December 2014: BLUEMED Vision Document presented by the Italian Presidency of the EU at the Competitiveness Council and endorsement of the process. October 2015: Adoption of the Venice declaration by 10 European countries and launch of the BLUEMED SRIA. October 2016: Starting of the BLUE-MED Coordination and Support Action. April 2017: BLUEMED Conference 'A Basin of Research and Sustainable Growth' under the Maltese Presidency of the EU Council and first SRIA update May 2017: Signature of the Valletta Declaration on Strengthening Euro-Mediterranean cooperation through Research and Innovation. The BLUEMED Initiative enters the agenda of the Member States of the Union for Mediterranean and the EU.



## The BLUEMED CSA

The BLUEMED project is funded by the European Commission within the H2020 framework programme with 3 M€, aimed at supporting the implementation of the BLUE-MED Initiative by promoting the update and implementation of the BLUEMED SRIA, converting its outputs into actions. It started on the 1st October 2016 and will last 4 years.

### How the CSA supports the BLUE-MED Initiative

To support the BLUEMED Initiative, the CSA will:

♦ Develop a set of indicators and assess relevant research infrastructures, data policies and skills to underpin the BLUEMED research and innovation actions
